APPLICATIONS WILL NOT BE PROCESSED UNLESS AND UNTIL THEY ARE COMPLETE

TO BE CONSIDERED COMPLETE, ALL REQUIRED ITEMS MUST BE IN THE POSSESSION OF THE MEMBERSHIP CHAIRMAN It is the responsibility of the MEMBER or APPLICANT to allow for delays with USPS and/or NRA Member Services.

A.-COMPLETE APPLICATIONS MUST INCLUDE:

- 1. ALL SIGNATURES of MEMBER and (if applicable) CO-MEMBER and MINOR AND/OR DEPENDENT CHILDREN over the age of 18.
- 2. Proof of NRA membership for MEMBER or CO-MEMBER (only one required) (See section F below for RENEWAL exceptions)
- 3. Payment for annual dues (RENEWAL only. DO NOT submit payment with a NEW application.)
- 4. For RENEWAL, all items (including payments) MUST be in the POSSESSION of the Membership Chairman by March 31st.

B.-RENEWAL vs. NEW (WAIT LIST) APPLICATION

- 1.-An application is a RENEWAL **ONLY** if the applicant is a CURRENT MEMBER when the application is submitted.
- 2.-If you are NOT a CURRENT MEMBER, you are a NEW APPLICANT, subject to the INITIATION FEE of \$100. This also applies to any former member **RE-APPLYING** for membership after a LAPSE in membership of one or more years.
- 3.-The \$100 Initiation fee is waived for active duty military members (military proof required)

C.-APPLICATIONS MAY BE SUBMITTED BY:

- 1.-USPS mail to PSC MEMBERSHIP, PO Box 1241, Poulsbo, WA 98370
- 2.-Delivery to the RSO on the Rifle/Pistol range
- 3.-Delivery to the Membership Chairman at a Club monthly membership meeting
- 4.-Email to <u>membership@poulsbosportsmanclub.org</u> (Emailed applications **MUST INCLUDE REQUIRED SIGNATURES**, which requires scanning or digitally photographing the application.)

D.-PAYMENT OF ANNUAL DUES AND INITIATION FEE (IF APPLICABLE):

- 1.-Must be by check, money order, and/or range point voucher obtained from the range point manager.
- 2.-Submit payment by methods C1, C2, or C3 above for submitting applications. For methods 2 and 3, PLEASE seal the payment in an envelope addressed to the PSC Membership Chairman.
- 3.-DO NOT SEND CASH. DO NOT USE A BILL PAY or THIRD-PARTY CHECK ISSUING SERVICE unless approved IN ADVANCE by the Membership Chairman. DELAY IN RECEIVING SUCH PAYMENTS WILL NOT BE AN EXCUSE FOR MISSING THE PAYMENT DEADLINE.

E.-NRA MEMBERSHIP

- 1.-Proof of NRA membership must be supplied to or in possession of the membership chairman for an application to be considered complete. Such proof need not be supplied with the membership application, but the application will not be added to the Wait List or processed for renewal until both the application and the proof of NRA membership are in the possession of the membership chairman. Either item or both may be delivered electronically or by USPS mail.
- 2.-Acceptable proof of current NRA membership is a single document that shows the following three items:
 - a.-The name of the PRIMARY MEMBER (or of the CO-MEMBER)
 - b.-The NRA membership number
 - c.-The expiration date of the NRA membership (or "LIFE", if applicable)
- 3.-Examples of such documents are:
 - a. A pdf copy of the NRA membership card as obtained from **nramemberservices.org** (sent by email). **This is the preferred method of providing proof.**
 - b. A photocopy (sent by USPS) or digital copy (sent by email) of the member's physical NRA membership card.

 Note: Some cards mailed by the NRA include the member's name and NRA membership number, but **DO NOT SHOW** the membership expiration date. These cards are **NOT ACCEPTABLE** as proof of current membership.
 - c. An original, or a photocopy, or a digital copy of a mailing label from an NRA magazine
- 4.-A copy of the home page from nramemberservices.org is no longer acceptable proof. This page shows NRA member number and membership expiration date but DOES NOT show the member's name (only the member's web site username). If you have an account at nramemberservices.org, follow the link on the home page to Print Your NRA Membership Card to generate a pdf copy as described in 3a above. This may be emailed directly to membership@poulsbosportsmanclub.org.

F.-EXCEPTIONS FOR NRA PROOF

- 1.-The Membership Chairman will post on the PSC web site a list of current members by member number. The list will show whether the Club records indicate that the member's NRA expiration date is compliant with the Club rules for 2021. If the list entry is NO, NRA proof need not be submitted with the application. If the list entry is YES (expiration missing or expired), NRA proof must be re-submitted.
- 2.-If the applicant cannot access this list, then NRA proof MUST be submitted. (EASY PAY LIFE memberships require re-submission.)
